- In terms of the leave measures, provisions exist for employees eligible for payment of leave gratuity payments to designate, if they so desire, one or more beneficiaries to whom their leave gratuity payment is to be effected in the event of their death. The percentage of the leave gratuity payable to each designee must also be indicated.
- The prescribed form for designating beneficiaries is attached hereto. Employees
 wishing to designate beneficiaries are required to complete and forward this prescribed
 form to the relevant HR Component. A new form must be completed and submitted
 whenever circumstances change, and which necessitates a change in the designation
 of beneficiaries.
- 3. In instances where an employee dies and has not designated any beneficiaries, the leave gratuity payment will be effected as follows:
 - a) In full to the spouse or life partner of that employee; or
 - b) If there is no spouse or life partner, in equal shares for the benefit of minor and other children (including legally adopted children) of the deceased who, at the time of death, were fully dependent on the employee; or
 - c) If there are no children, to the employee's estate.
- 4. It must be emphasized that the leave gratuity payment will be effected to designated beneficiaries only upon the death of the employee. In respect of other exits, the leave gratuity payable will be remunerated directly to eligible employees.
