AND 5 SCHOOLS ON PHASE 2 OF THE BASIC EDUCATION

EMPLOYMENT INITIATIVE

DATE: 23 SEPTEMBER 2021

- Eastern Cape Department of Education in collaboration with Department of Basic Education is embarking on the implementation of Phase 2 of the Basic Education Employment Initiative (BEEI).
- 2. The BEEI is meant to create employment opportunities for the unemployed youth by creating decent jobs and meaningful experiential learning.
- 3. The youth will also assist to capacitate schools to manage the impact of Covid-19 on schooling, whilst supporting the Basic Education Sector as it repositions and re-imagines the future beyond Covid-19.
- 4. The targeted youth will be placed in Public Ordinary and Special Schools.





- 5. The BEEI Phase 2 implementation came with a new framework which entails that all Quintile 1 -3 schools have compulsory participation in the initiative.
- 6. Quintile 4 5 schools participation in the initiative will only be considered for schools who would have indicated their interest to be part of the initiative.
- 7. Note that in Phase 2 of the BEEI implementation no transfers are to be made to schools for savings of posts.
- 8. Focus of the BEEI Phase 2 will be on providing Educator Assistants and General School Assistants to schools, details of intervention to be implemented in the Phase 2 are as follows:
