## 1. Purpose

The purpose of this memo is to remind all schools of the requirement to submit Term 1 data by no later than 10 April 2025, in accordance with the annual EMIS reporting schedule.

# 2. Background

In terms of EMIS Instruction No. 3 of 2025, the Department outlined the key calendar events and reporting timelines for the year. Among these is the submission of Term 1 data, which forms a critical component of education planning, monitoring, and reporting.

Furthermore, schools are reminded of their legal obligation to provide accurate and timeous information to the Department as stipulated in the South African Schools Act, 1996 (Act 84 of 1996) and other relevant statutory prescripts.

### 3. Directive

All schools are hereby instructed to submit their Term 1 data on or before 10 April 2025. Noncompliance with this directive may result in administrative follow-up and could potentially impact decision-making processes dependent on this data.
