SUBJECT: ASSET VERIFICATION 2025/26

Section 45(e) of the Public Finance Management Act (PFMA) tasks all officials with the responsibility to manage and safeguard assets within their areas of responsibility. Treasury Regulations (RSA, 2005) further places the responsibility on the accounting officer for ensuring that control systems are in place to ensure the prevention of theft, losses, wastage, and misuse of assets and the keeping of stock levels at an optimum and economical level.

The departmental Asset Management policy section 9.12 requires all assets of the department to be physically verified and confirmed at least once in a financial year to ensure the completeness and correctness of assets on the fixed asset register.

This is to notify all the officials that the Logistics and Disposal Management office team will be conducting a full asset verification and spot checks which include all districts. We would like to request all officials to kindly avail themselves and their gadgets to be verified by the Asset Management verifying team and all offices to be opened during this period.
