# SENIOR CURRICULUM MANAGEMENT TERM 4 PRIORITIES AND MANAGEMENT PLAN

#### 1. PURPOSE

The purpose of this Curriculum Instruction is to outline to all teachers and curriculum officials supervising grades 10 - 12, the FET Curriculum priorities and management plan for Term 4 of 2021.

#### 2. BACKGROUND

Due to the unprecedented disruption of Covid-19 on the education system in South Africa in 2020, there is a considerable reduction in time to support, monitor and evaluate teaching and learning in schools offering grades 10 - 12. In addition, austerity measures have impacted heavily on face-to-face development programmes for teachers and subject advisors.

In order to mitigate the impact of Covid 19 disruptions on the implementation, monitoring, support and evaluation of FET programmes and activities in 2021, the Department has developed a Term 4 Management Plan attached as Annexure A to the curriculum instruction.

The Term 4 Management Plan is designed to draw attention to timeframes for the implementation of the key priorities such as but not limited to the following:

- Analysis of results for all grades.
- Response plans and strengthening of intervention programs.
- Accountability sessions

- Strengthening, implementation and monitoring of Last Push Activities
- Subject Committee Meetings
- Implementation of Subject Improvement Plans (SIP)
- District-Based catchup plans to cover the prescribed curriculum as per Recovery ATPs.
- School Based Assessment and districts' readiness for end-of-the year assessment for grades 10 – 12.
- SBA/PAT/PET/Oral Moderation
- Evaluation of the NSC Examination Question Papers
- Grade 10 12 Learner Support Programmes through intensified revision activities.
- Monitoring and support of Study Camps
- Compilation and submission of Term 3 SBA reports.
- Management and submission of computerized marksheets.
- Pre-moderation and post-moderation of grades 10 11 assessment tasks.
- Sampling of grades 10 and 11 scripts for post-moderation, question-by-question analyses and development of diagnostic reports.

### 3. CONCLUSION

The implementation of the Term 4 Management Plan takes place immediately upon the reopening of schools on the 11 October 2021. All FET curriculum officials, SMTs and teachers are requested to plan for all activities as outlined and to build district support, monitoring and evaluation plans around the dates contained in the management plan.
